



Butchering Babies for Medical Advancement and Science

Modern medical science has clearly shown us that human life begins at conception.

- At conception a new human being begins, complete with his or her own unique set of DNA, which is present from the first day of life. The new little person's sex is also determined from the beginning.
- Eighteen days after conception the baby's heart is beating.
- During the first month the baby grows to 10,000 times his/her size at conception.
- She or he moves six weeks after conception though the mother does not yet feel the movements.
- At eight weeks every part of the body found in an adult is already in the baby in miniature form.

- At eleven weeks after conception the baby has finger-prints and the finger nails are growing.
- At twelve weeks the baby's lips open and close. S/he can wrinkle his/her forehead, raise his/her eyes, turn his/her head, smile and frown.
- At sixteen weeks s/he reacts to sound, sucks and swallows, may get hiccups, yawns and stretches.
- Although moving since six weeks, at eighteen weeks the mother now feels the movements. The baby pushes with his/her feet and head to exercise and tone his/her developing muscles and also sucks his/her thumb. His/her toenails, hair, eyebrows, fringe of eyelashes on closed eyelids are growing.
- At twenty weeks the baby sleeps and wakes and is fully able to hear.
- At twenty four weeks the baby may possibly dream and can make a fist and punch it against his/her mother.
- By twenty-five weeks the baby in the womb has the ability to hear like that of an adult and can discern the moods and attitudes of its mother. So we obviously want happy Moms so that we can have happy babies!

This account of the miracle of life growing in a mother's womb leads us to ask, "Are expectant mothers so busy that they do not give enough time to contemplate the miracle that is taking within them?" Yes, I suppose mothers can forget about the miracle occurring inside their womb but this miracle should cause us to bow our knee and worship the Creator!

Psalm 95:6 should be our response:

"O come, let us worship and bow down: let us kneel before the Lord our maker."

Prop: God hates abortion and the selling of baby organs.

There are three reasons why God hates this practice.

I. Because life begins at conception.

Is a baby living inside the womb of a mother a child? The Bible gives us a very clear answer to this question. It does not matter what the abortion doctors or politicians say. Here is what God says.

Psalm 139:14-16

“I (*indicating personhood*) will praise thee; for I am fearfully and wonderfully made (*God’s formation of the baby within the womb*): marvellous are thy works; and that my soul knoweth right well (*the development of a baby is a marvelous work of God*). My substance (*the early stages of the development of a baby that follows conception*) was not hid from thee, when I was made in secret (*God creates life in the secret of the mother’s womb*), and curiously wrought (*skillfully woven together – God is the Divine Weaver*) in the lowest parts of the earth (*a metaphorical expression describing the mother’s womb*). Thine eyes did see my (*indicating personhood*) substance, yet being unperfect (*the unformed mass of a baby from conception to its early stages of development*); and in thy book (*God’s mind is compared to a book of remembrance of all living people – including babies inside the womb!*) all my (*indicating personhood*) members (*members of the human body*) were written, which in continuance were fashioned (*molded – God is the Divine Potter*), when as yet there was none of them” (*even before all the hands, feet, legs, arms, and fingers of the baby are formed, God had them recorded down, and throughout the course of time the folded unperfected mass of a baby developed and became a fully formed baby*).

In a speck of watery material smaller than the dot over the letter “i” all the future characteristics of the child are programmed - the color of his skin, eyes and hair, the shape of his facial features, the natural abilities he will have. All that the child will be physically and mentally is contained in germ form in that fertilized egg. From it will develop: “60 trillion cells, 100 thousand miles of nerve fiber, 60 thousand miles of vessels carrying blood around the body, 250 bones, to say nothing of joints, ligaments and muscles” (Radmacher). We are “fearfully and wonderfully made” (Ps. 139:14).

Here is the point; in the mind of God, which is compared to God’s book of physical life (the record of all human life), God had David’s physical life recorded down, when his life began in the womb. In the mind of God, poetically referred to as the book of God, the blueprint for life is clearly charted, so that from the very moment of conception God begins to fashion the members of the body, even before they are recognizable.

We discover from these verses that during the earliest stages of child development, even before there was a recognizable formation of the baby, David was a person. In fact, personal pronouns are given to him (“I am”; “my substance”, I was”). This means that life begins at the moment of conception. It is little wonder that those who have faithfully followed the Judeo-Christian faith have always understood life to begin at the moment of conception and not at birth. David describes his formation in the womb of the mother as being fully human. He does this by ascribing personal pronouns to himself while God was miraculously weaving him together as a little child. David’s life was already recorded in the book of the living when he was inside the womb. He was a real human being. Personhood is ascribed to David as an unformed baby in the womb which began at conception. This means that God denounces and despises the “morning after” pill. This is because it kills a baby that has been conceived in the womb of a mother.

II. Because abortion is murder.



God’s moral laws NEVER change. Exodus 20:13 commands, “Thou shalt not kill.” Murder is the unlawful taking of someone’s life (Exodus 20:13). Here is just a small sample of the Biblical passages forbidding murder or the unlawful taking of human life (Gen. 9:6, Matt. 15:19, 19:18, Mk. 10:19, Lk. 18:20, Jn. 8:44, Acts 3:14, Rom. 1:28-29, 13:9).

Since a baby is a person or human being, under the Mosaic Law there was a death penalty given to someone who killed a baby that was inside the womb of a mother.

Exodus 21:22-25 records God’s command:

“If men strive (have a fight), and hurt a woman (by inadvertently hitting a woman during the fight) with child (a pregnant woman), so that her fruit depart *from her* (she experiences a premature birth of a child but the child lives), and yet no mischief (injury or harm) follow: (the child is not harmed) he shall be surely punished, according as the woman's husband will lay upon him; and he shall pay as the judges *determine*. And if *any* mischief (injury or harm) follow (the child died), then thou shalt give life for life, Eye for eye, tooth for tooth, hand for hand, foot for foot, Burning for burning, wound for wound, stripe for stripe.”

Under the Mosaic Law the Scripture prescribes the same penalty (death) for someone who causes the death of a baby in the womb as for someone who commits murder. This clearly indicates that God considers a baby in the womb to be as human as a full-grown adult and this is what Psalm 139 and other verses teach.

Premise #1: It is wrong to murder a person.

Premise #2: The unborn is a person.

Conclusion: Therefore, it is wrong to murder the unborn.

This poem was written by Kate Hosking at the age of 14 and reveals the inner cry of a baby whose life was taken away.

“Mummy, why are you crying so?
I wish I could hug you, don't you know?
I can feel all your pain deep inside me
I'm just like you, if only you could see.

Can't you tell him to go away
He's not my daddy so why let him stay?
He's hurting you again Mummy, isn't he?
Oh mummy, I hurt, why can't you see?

My room, so warm, is now getting cold.
Mum, it's not time, I'm not very old.
I'm yours Mummy, yours not these men in white.
I'm scared, Mummy, scared but I'm going to fight.

Mummy, I'm slipping, catch me please!
These people in white won't let me breathe.
Oh mummy, I wish you could hold me just this one time
My emotions are creeping over me and I'm starting to cry.

Mummy, I thought that you loved me so,
Now I know that's a lie because you let me go.”

Viewing abortion as a simple, convenient procedure is totally psychologically and sinfully misguided. Mothers who have chosen to abort often face feelings of sorrow, shame, and guilt. The body will physically heal after an abortion

given time, but the psychological scars left behind may never totally fade away.

III. Because God is against harvesting baby body parts.



The organization that has released many videos exposing the scandal of Planned Parenthood which involved selling aborted babies and their body parts has released some new undercover videos with shocking discoveries. One of the videos catches the nation's biggest abortion business harvesting the brain of an aborted baby who was still alive. We are now learning that Planned

Parenthood may actually be keeping some babies alive after the abortion procedure in order to better collect their organs for harvesting — such as their hearts.

This video and others contain heart wrenching admissions about the absolute barbarism of Planned Parenthood's abortion practice and baby parts sales in which babies are sometimes delivered intact and alive. There can be no question about what this organization is doing. They are butchering babies and selling their body parts. Planned Parenthood is not only a godless organization but a criminal organization from the top down and should be immediately stripped of taxpayer funding and prosecuted for their atrocities against humanity. There should be no debate. This nation needs to shut down this butcher house of humanity.

Margaret Sanger founder of Planned Parenthood, leading the parade in abortion, said, "The most merciful thing a large family can do to one of its infant members is kill it." Planned Parenthood is a butcher shop. We live in a time when abortion is being practiced at alarming rates and babies are being murdered at epidemic proportions. We now have learned that Planned Parenthood is also selling the body parts of babies for scientific and medical research for the alleged improvement of medicine and society. This is the new moral low for our society today.

During an extended interview, Nancy Pelosi said she is "proud" of the president of Planned Parenthood. How can any person with a conscience say these things? Some of these people in Washington are being led by demons. In fact, any person who can destroy the life of a baby without blinking an eye and rip out their body parts has to be desensitized and directed by demons.



The kind of thing that occurring in our country today is a barbaric practice that demonstrates the lowest part of human nature which is left without God's light and voice.

Some are concluding today, "Well, if they use the body parts of aborted babies for science and medical research it's ethically okay to kill babies." Then there are others who will say, "Yes, abortion is a moral atrocity but we might as well make the best of a bad situation and use the body parts of babies for medical advancement."

Does this kind of reasoning have Biblical support?

There are five reasons why God hates the harvesting of baby body parts.

1. This practice promotes heathenism.

Jeremiah 10:2 says, "Thus saith the LORD, Learn not the way of the heathen." The New Testament adds to this truth when it states: "Come out from among them and be ye separate saith the Lord" (2 Cor. 6:17).

The abortion of babies and selling of body parts for science and medical advancement is heathen barbarism and a hellish work of the devil. This practice is heathenism 101. Our society, which is rapidly turning away from God and the light of revelation, is becoming like the ancient civilization of Vikings who were nothing more than pirates who plundered the coasts of Europe in the 8th and 10th centuries. They were barbarous people that killed and murdered everyone and had no conscience.

The truth needs to be told. Satan has always been a promoter of the heathen practice of killing babies for the advancement of manmade goals and artificial purposes.

Exodus 1:15-16

“And the king of Egypt spake to the Hebrew midwives, of which the name of the one *was* Shiphrah, and the name of the other Puah: And he said, When ye do the office of a midwife to the Hebrew women, and see *them* upon the stools; if it *be* a son, then ye shall kill him: but if it *be* a daughter, then she shall live.”

In spite of the Egyptians ruthless treatment of the Israelites, God prospered them numerically and they increased in power. This caused greater concern for the Egyptians and they began to think that someday the Israelites would side with their enemies and outnumber the Egyptians and overtake them during the time of war. As a result, Pharaoh ordered all the male babies to be killed, since they would be a threat as possible warriors during the time of war. This was Pharaoh's purpose for murdering babies. Was it justifiable in God's eyes? Absolutely not. Nothing justifies the killing of babies. Man's goals and purposes for murdering innocent children are debunked.

We find in Scripture that three different evil rulers ordered the slaughter of innocent children: Pharaoh, Athaliah (2 Kings 11), and Herod (Matthew 2).

2 Kings 11:1

“And when Athaliah the mother of Ahaziah saw that her son was dead, she arose and destroyed all the seed royal.”

Matthew 2:13

“And when they were departed, behold, the angel of the Lord appeareth to Joseph in a dream, saying, Arise, and take the young child and his mother, and flee into Egypt, and be thou there until I bring thee word: for Herod will seek the young child to destroy him.”

Athaliah wanted the throne and Herod was jealous of his throne and sought to get rid of the prospective male kings. But Satan's underlying purpose for killing these babies was to destroy the royal line through whom Christ would come. These satanically inspired atrocities were ultimately aimed at the extinction of the Messianic line through whom Christ would be born. Satan had never forgotten God's promise in Genesis 3:15.

Satan's agenda in this day was to keep Christ from coming into the world. His agenda today in instigating the acts of abortion is to dethrone God, get rid of His moral or ethical code, and man's accountability to the Creator.

In Leviticus 18:21 we read of another baby butchering:
And thou shalt not let any of thy seed pass through *the fire* to Molech, neither shalt thou profane the name of thy God: I *am* the LORD.

Leviticus 20:2 adds:

“Again, thou shalt say to the children of Israel, Whosoever *he be* of the children of Israel, or of the strangers that sojourn in Israel, that giveth *any* of his seed unto Molech; he shall surely be put to death: the people of the land shall stone him with stones.”

In the Old Testament there was a heathen practice of offering young children to the pagan god Molech. This practice of killing babies was justified in the name of pagan religion. This was a heathen and hellish practice.

You gasp, “Why, I would never condone and accept the practice of throwing babies and little children into the fire.” Maybe not, but how can you conclude that it's ethically okay to extract the organs of aborted babies for medicine and science before throwing the baby in a dumpster or cremated by fire? How much different is this practice then throwing babies in to the fire? Other babies are shipped off in containers and sealed buckets to pathology labs for research. There are many horrifying stories that could be mentioned but their practices are so horrifying they are not fit to speak about.

The point is this; whether you burn babies in the fire or cut them up like animals, and ship their organs and bodies off to other butchers, makes no difference to God. These are all barbaric and heathen practices that are fueled by Satan and demons. 1 Corinthians 10:20 says, “I would not that ye have fellowship with demons.” We should never condone, promote, or ethically justify the practice of demons! God forbid that we would do this by becoming soft on the selling of baby organs for medical science. This is a demonized practice. Demons are behind it and Christians should never promote it in any way.

Killing babies without a conscience and using their body parts for manmade goals and purposes, whatever the purpose might be, is a godless and

heathen practice and is what unsaved people do who have no fear of God. The Bible says in Romans 3:18, "There is no fear of God before their eyes."

The Bible teaches that Christians are to have no part or acceptance with this type of barbaric heathenism. We had better stop kowtowing (bowing) to heathenism. We cannot cave to the culture when the culture is morally debunked.

Romans 12:2 says:

"And be not conformed to this world: but be ye transformed by the renewing of your mind, that ye may prove what *is* that good, and acceptable, and perfect, will of God."

When Christians conform to the culture and accept the practice of using the organs of aborted babies for medical advancement and research, they demonstrate just how worldly and morally desensitized they have become to God's standard of righteousness and holiness. God has called us to be directed in "paths of righteousness" (Ps. 23:3) and not paths of wickedness and vileness.

2. This practice invokes pagan philosophy.

We might say that we hate abortion but then conclude that it's okay to use the body parts of babies for medical science. However, this kind of reasoning is invoking or supporting and appealing to the pagan philosophy which states: the end justifies the means.

The Bible talks about this heathen practice when recording what godless and heathen people conclude: "Let us do evil that good may come" - Rom. 3:8). In the context, people were saying that if sin (Israel's unfaithfulness or man's unrighteous living) magnifies the glory of God (His faithfulness and righteousness) when placed alongside these sinful ways, then the more sin the more glory God gets. In essence, God is okay with moral atrocities if He does get the glory through them. In other words, the END (God's glory) justifies the MEANS (sin and wrongdoing).

Some had falsely accused Paul of teaching this absurdity that somehow sin is okay and God is okay with sin, as long as He gets the glory. Of course, this is ridiculous since it was Paul who insisted that God must judge sin and the sinner ("whose damnation is just") which PROVES God never condones

sin. As surely as there is sin there must be judgment. We might add that God does not condone the aborting of babies and selling their body parts just because some alleged goodness will come about from such an evil practice. People of the world are saying today that we can do evil (abort babies) if we get some good out of it (medical advancement within society). The philosophy that says that the end (the end result of something that might be good – medical advancement) justifies the means (the butchering of babies). This is a perverted way of thinking. Paul says “God forbid” (vv. 4, 6) to this philosophy. This is an expression which indicates a recoiling abhorrence, utter shock, and disgust. This philosophy is so reprehensible that no Christian should ever think of imbibing this paganized theory. We must stop accepting and condoning worldly philosophies.

Colossians 2:8

“Beware lest any man spoil you through philosophy and vain deceit, after the tradition of men, after the rudiments of the world, and not after Christ.”

The end does not justify the means. This kind of philosophy is “vain deceit” which means that it is nothing more than empty sounding delusion and trickery. Killing babies and cutting out their organs for human research is a vain practice. Don’t be fooled by what people are saying. “It’s okay as long as some good comes out of this.” No, it’s not okay.

Don’t be fooled into thinking that it’s okay to harvest the organs of aborted babies if there is an honorable goal. There is no honorable goal for cutting up babies, tearing out their organs and then burning or cremating them in fire or turning them over for further butchering. No advancement in medical research or science can ever meet God’s approval when babies are being slaughtered. As Christians, we should never conclude that the end justifies the means. We should never overlook the moral atrocities that are occurring in our country with the idea that some good can come out of such depraved and despicable actions of slaughtering babies.

3. This practice yokes together believers with unbelievers.

As Christians, we are called upon to separate from pagan philosophies and those who practice pagan and wicked customs. We are to have no part with their heathen ways. The Bible makes this unmistakably clear. Stop supporting heathen and wicked practices. We are called upon to separate

from heathen customs and not join up with the devil's evil agenda during these last days.

2 Corinthians 6:14 commands us as Christians:

“Be ye not unequally yoked together with unbelievers (in evil and morally degrading practices): for what fellowship hath righteousness with unrighteousness? and what communion hath light with darkness?”

Let me give you an illustration of what unrighteousness and darkness is. When someone forcibly extracts a baby from a mother's womb and then kills that baby, cutting out the babies organs in the name of science, this is darkness! This is unrighteousness. It is evil. This practice is so dark that it hurts to even speak about such atrocities.

This is the work of Satan!

2 Corinthians 6:15 goes on to say:

“And what concord (fellowship or agreement) hath Christ with Belial? or what part hath he that believeth with an infidel?”

Who is behind the butchering of babies? It's Satan. Belial is another name for Satan which means the worthless one. Satan is a worthless good for nothing type of spiritual being. The Bible is teaching that we actually team up with Satan's agenda, the worthless one, when we promote the moral atrocities of butchering babies and the harvesting their organs. Folks, this is Satan's agenda – not God's. Let's stop playing Satan's game. God has called us to separate from heathen people, infidels who are murdering babies, and from Satan's agenda in society.

God has commanded us to not yoke together, or be tied together with unsaved people in their pagan and sinful ways. He has called us to live separate from pagan customs and practices. And He has surely commanded us to not promote Satan's End Time agenda in this world.

2 Corinthians 6:17 once again commands us to “come out from among them and be ye separate saith the Lord and touch not the unclean thing.” What part of this command don't we understand? In other words, we are called upon to never adopt their godless ways, ideologies, and heathen practices. God has called us to separate from all wicked practices and heathen ways

within our society and specifically commands us to “not touch the unclean thing.”

I’m shooting straight and I will not miss my target in this study. The butchering of babies and selling their body parts for medical research is an unclean thing! It’s a moral atrocity! It is a pagan practice that defies all decency, virtue, and ethical soundness.

Planned Parenthood officials have clearly said that the money or income being generated by the selling of baby body parts generates income for abortion clinics. Of course, this means they can continue their barbarous acts of murdering millions of babies. Do you want to promote abortion? Do you want to put your stamp of approval on abortion? This is exactly what you do when you are a supporter of the selling of baby organs for research.

Let’s be clear about this. Planned Parenthood Uses Partial-Birth Abortions to Sell Baby Parts. Planned Parenthood officials are proud of being able to harvest “fresh” babies’ organs, including eyes and genitals, and admit such practices “generate a fair amount of income.” And this results in the butchering of more babies.

Speaking about the “unclean thing” (2 Cor. 6:17), Job 14:4 asks a timeless question and then gives an answer: “Who can bring a clean *thing* out of an unclean? not one.” The Bible teaches that you cannot bring a clean thing (medical advancement and good) out of something that is unclean or wicked (the abortion of babies). This means you cannot justify medical advancement over the death of over 50 million babies! Nothing can be considered good, ethical, virtuous, and right when it comes about through sinful and horrible atrocities. You CANNOT bring a clean thing out of something that is dirty and rotten. Dirt breeds more dirt. Only clean things bring forth clean things.

Again, if we give in to the use of the organs of aborted babies for any reason whatsoever, we are actually condoning, endorsing, and putting our stamp of approval on the “unclean thing” which we are called upon to separate from, which in this case is the untold millions of aborted babies that have been aborted in this country.

Here are some recent statistics. If one assumes that the 1,120,775 number held constant from 2011 to 2013, the total number of abortions would be 54,972,980. But one researcher Guttmacher concedes that it might

undercount the number by 3%. Add that 3% and it yields a total of 56,662,169 abortions since 1973.

We must come to grips with the reality and fact that the use of body parts and the organs of babies for medical advancement and scientific research or knowledge belittles the terrible and horrific act of abortion. It's like trying to bring a clean thing out of something that is unclean. It's impossible to do. This is what the Bible teaches. This is God's enduring principle.

4. This practice revokes God's moral code.

1 Timothy 4:2 speaks of the desensitization of America:

“Speaking lies in hypocrisy; having their conscience seared with a hot iron.”

When one adopts this type of hideous practice of ripping out the organs of babies for medical advancement their conscience has become desensitized to the moral atrocity that is actually happening and occurring today in America. One thing is certain, butchering babies and selling their body parts is the lowest of the low. It demonstrates the total depravity of human nature (Rom. 3:10-18).

Romans 1:18-19 reveals this:

“For the wrath of God is revealed from heaven against all ungodliness and unrighteousness of men, who hold (suppress) the truth in unrighteousness; Because that which may be known of God (His existence, moral code, and man's accountability to God) is manifest in them (in their conscience); for God hath shewed *it* unto them.” Romans 2:15 adds a footnote to further explain: (...“Which shew the work of the law written in their hearts, their conscience also bearing witness, and *their* thoughts the mean while accusing or else excusing one another”).

Here is the point. When we become desensitized by the cultural practices in America we begin to suppress what might be termed as a general light of reason, truth, and morality that is present within the conscience of the human race. This is what happens. We move from aborting babies to now selling their body parts to the highest bidder on the market. Anyone who can condone this practice has a conscience that has gone AWOL. It is missing in action! You have turned God's moral code upside down.

Isaiah 5:20 says:

“Woe unto them that call evil good, and good evil; that put darkness for light, and light for darkness; that put bitter for sweet, and sweet for bitter!”

As Christians, we need to possess a conscience that is guided by the eternal truth of God’s Word (John 17:17) and allow our conscience to be pure (2 Tim. 1:3) and undefiled (Titus 1:15).

Can you honestly say that abortion is wrong but then turn around and say that the use of aborted baby organs is okay if they are being used for a good cause? This is like saying that it’s terrible to molest a child but then turn around and say that is okay if we can learn something about child molesters through this terrible experience. This kind of vain reasoning is preposterous and morally warped!

Is it okay to harvest body parts of aborted babies? If you really think that harvesting baby organs from aborted babies is permissible if we somehow we can get some good out of this evil practice, then you are no better than the doctors of death, who are slaughtering these innocent babies and selling their parts for money, without possessing any conscience for committing such a dastardly deed.

I want to put you to the test. I want you to answer some questions if you really think that the harvesting of baby organs is an ethical practice. Could you view a recently aborted baby, which is lying in front of you, and not be absolutely horrified by what someone has done to this child? Answer this from your own conscience. Could you then proceed to actually extract the organs from this recently aborted baby and try and sell them to the highest bidder on the market and not have any conscience in doing this? And finally, even worse, what if it were your own baby?

I’m making a valid point in asking these questions. I’m cutting through all the political rhetoric of today. Could you cut out the organs of your own baby? If you are offended by these questions then you have answered the question whether or not it’s ethical to use the organs of butchered babies for medical advancement. If you say, I would never and could never do such a hideous and reprehensible thing, I could never kill a baby and then extract its organs for medicine and science, then you have answered the question: “Is it ethical to kill babies in order to use their organs for medicine and science.”

In short, a conscience that has not been warped by a paganized society will see the harvesting of baby body parts as something that is absolutely reprehensible, dreadful, and a heathen practice. If God hates the butchering of babies; He most certainly despises cutting out their organs to be sold on the black market to be used for man's intended goals or purposes.

David Daleiden, director of the Center for Medical Progress, the organization that has released the videos exposing Planned Parenthood, summed up as follows: "Today's video contains heartrending admissions about the absolute barbarism of Planned Parenthood's abortion practice and baby parts sales in which fetuses are sometimes delivered intact and alive. Planned Parenthood is a criminal organization from the top down and should be immediately stripped of taxpayer funding and prosecuted for their atrocities against humanity."

I agree with this wholeheartedly and so should every Christian who has a conscience guided by the truth of God's Word.

5. This practice provokes God's judgment upon America.

God must judge America for this horrifying moral atrocity. It cannot and will not be left undone. If you think for one moment that we are going to get away with this type of godlessness and barbarism then you are absolutely fooled.

Psalm 2:4-5 declares this against the wickedness of man:

Psalm 9:17 reveals:

Matthew 5:14

"Ye are the light of the world. A city that is set on an hill cannot be hid."
